

LETTER FROM THE BOARD

Dear Supporters,

Impossible Possibilities (IP) turned 15 years old in 2022. The students from our inaugural scholarship class of 2009 are now a decade removed from graduation and are building successful careers in their respective industries, while our most recent scholarship recipients completed their fall semesters as incoming college freshmen.

IP scholars, then and now, are a determined group of individuals working and studying in various fields, including business, education, engineering, law, medicine and social work. Of our 110 total scholars, 68% are female and 32% are male. African American and Hispanic students make up the largest ethnic demographic, comprising 26%, respectively, followed by Caucasian at 22%. Asian at 10%. and Other at 16%.

The scholars, including four international students, have attended, or currently attend, one of 37 schools. Thirty percent have attended, or currently attend, an Ivy League school, Historically Black College and University, or private college. The university with the most IP scholars represented is the University of Texas at Arlington at 16%, followed by a tie between the University of Texas at Austin and Texas A&M University at 11%, respectively. Go figure!

Overall, IP scholars represent the diverse communities found throughout North Texas, and based on the scholarship applications received to date, we expect the 2023 class to be more of the same.
